
TRUST DEED

I. DECLARATION OF THE DEED: This Deed of Trust is declared and executed at Mysore on this second day of December Two Thousand Four, i.e., 02.12.2004 by

The Trustees at Serial Number 1 - 4 above are the serving members of the Karnataka State Police, whereas Serial Number 5 - 7 are the retired members of the Karnataka State Police, and Serial Number 8 and 9 are the reputed members of the Public having come together for the common concern towards the welfare of the families of the members of the Karnataka State Police. All of them have agreed to act as the Trustees and are designated as the "**Founder Trustees**" of the Trust.

II. NATURE OF THE TRUST: This Trust is founded out of deep concern of the Trustees for the welfare of the families of the members of the Karnataka State Police who while attending to the call of their duty irrespective of the place and time are not in a position to attend to the familial and social obligations specially the growth and development of their children, the most important aspect of which is providing the opportunity for quality education. It is a Non-Governmental, voluntary, secular and development-oriented organization consisting of people of different sections with a common concern.

III. AIMS AND OBJECTIVES:






















1. To establish and to run educational institutes with or without residential facility for the children of the members of the Karnataka State Police right from Nursery till Degree courses.
2. To establish and run vocational, technical and professional institutes, for example, medical and engineering colleges, Management Schools, Computer and industrial training centers, physical education, etc.
3. To establish and create necessary environment for the holistic development of the children while undergoing formal education.
4. To provide necessary modern infrastructure like laboratories, libraries, hostels, computers, etc. free or otherwise.
5. To provide for scholarships, partial or full, prizes or awards to the deserving students either in India or abroad and to give all other help for advancement of education in any field.
6. To provide for the opportunity of placement to the students completing the requisite course.
7. To promote and provide for the opportunity to the children to excel in other fields like sports, arts, dance, theatre, music, and other extra-curricular activities.
8. To provide for the informal education, adult education, gurukul education, etc.
9. To integrate the Police children with other children in a healthy and competitive environment.
10. To undertake any other welfare activities like health-care, family counseling, old age home, etc. depending upon the necessity of the place and time and in furtherance of the objective of the Trust.

IV. THE CORPUS OF THE TRUST: The Trustees contribute Rs. 1,000.00 (one thousand Rupees) each to the corpus of the Trust thus totaling to Rs. 9,000.00 (nine thousand Rupees) for the aims and objectives as detailed above and divest themselves of all personal interest in the same hereby declaring it to be the property of the Trust. The Trust property includes contributed amount as well as all other property, movable and immovable, and money that the Trust may receive from any other person or otherwise hold, by way of purchase or any other mode of acquisition or by way of donation or by way of interest accrued on the Trust property, dividends on shares, rents or other income and other accumulations howsoever made and any other investments representing the Trust property for the time being and from time to time existing.


V. THE BOARD OF TRUSTEES: The affairs of the Trust shall be managed by a Board of Trustees herein referred to as the **Board**.

V.1. Composition: The Board will consist of a maximum of nine members as below.

V.2. Nomination: The Founder Trustees named in the beginning of this Deed constitute the present Board. The first four members are **ex-officio** Trustees of the Board. The other five members of the Board will have a **tenure of five years**. They will be nominated by a majority decision of the Board after every five years. The previous member will be eligible for re-nomination. In case of vacancy caused by death, resignation or otherwise of any Trustee other than the ex-officio members, the remaining Trustees of the Board may fill up the vacancy by co-opting a suitable person as a Trustee by a majority decision for rest of the tenure.

V.3. Meeting: The Board shall meet at least once in a month and as often as may be necessary for the efficient conduct of the business of the Trust, such meeting shall be called by the Secretary and presided over by the Honorary/Executive President, in his absence the Secretary/Joint Secretary. The quorum for the meeting will be 1/3rd members of the Board of Trustees. All questions arising for decisions shall be decided by majority. In case of difference of opinion amongst the Trustees as to whether a particular act should be done or omitted to be done in the execution of the objective of the Trust hereof or as to the powers and authorities herein contained or as to the true intent and meaning of any of the clause of the Trust hereof the same shall be disposed of and dealt with in accordance with the opinion of the majority which shall be final and conclusive.

V.4. Office Bearers: The following five among the Board will hold the offices as shown against their names and will be invested with such power as the Board deems fit for the administration of the Trust.

1. Sri Kempaiah - Honorary President
2. Sri Praveen Sood - Executive President
3. Sri Vipul Kumar - Secretary
4. Sri H.R. Bhagawan Das - Joint Secretary
5. Sri B.P. Uttappa - Treasurer

The first four office bearers being ex-officio Trustees will hold the office for the period of their present posting in Mysore. Their offices will be automatically transferred to the new persons posted in their place in case of transfer or otherwise. The Board will have the freedom to shift these four offices among them. The fifth office bearer, the treasurer, is one among the three retired members of Karnataka State Police and will hold the office for five years unless he/she resigns voluntarily or is removed for the reasons as the Board may deem fit. In such case, the Board will appoint in his/her place one of the other two members by a majority decision. If required the Board may create additional

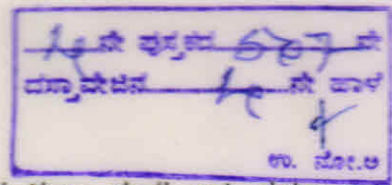

office. The services of office bearers are honorary and they shall not claim any remuneration or share in the income of the Trust.

VI. POWERS AND FUNCTIONS OF THE BOARD: The Board will be the supreme body of the Trust. It is fully empowered to carry out the aims and objectives of the Trust in any manner it deems fit including amendment to this Deed provided such amendment is not contrary or inconsistent to the aims and objectives as laid down earlier and the relevant law in force.

1. In furtherance of the aims and objectives of the Trust the Board shall have power to establish or conduct any institution for carrying out the above-mentioned objectives.
2. The Board may appoint committees, advisory or governing bodies for all or any of its institutions and it may delegate its power to such bodies or others or to some of their members upon such term and conditions as it thinks fit.
3. The Board may make such by-laws, rules and regulation for the conduct of the affairs of the Trust and its institutions and amend or rescind all such rules from time to time as it deems fit.
4. For carrying out any of the said powers or objects, the Board shall be entitled to utilize any part of the Corpus of the Trust property for making any capital investment. All such investments can be made in the name of the Trust or as required by the terms of investment.
5. The Board shall, in the first instance, collect the dividends, interest, rents, profits and other income of the Trust property and from and out of the same in the first place, shall pay all costs, charges and expenses incidental to the collection thereof.
6. The Board shall apply and try to obtain all concession, benefits and allowances as are available, in law in the matter of taxation, investment and exemptions.
 - a. The Trust shall be registered U/S 12A, 80G, 35CC and other sections of the Income Tax Act 1961 for the purpose of meeting the objectives of the Trust.
 - b. The funds of the society shall be invested in the mode specified under the provisions of section 13 (1) (d) read with section 11 (5) of the Income Tax Act 1961 and as amended from time to time.
 - c. That the Board shall cause proper accounts to be kept of the Trust premises and all additions thereto and the income there of respectively and accumulations of such income and the application thereof from time to time and shall on checking the same sign the account books, once in a year. The account books shall be audited and certified by one or more properly qualified auditor or auditors once in each year and the audited statements of accounts shall likewise be signed by all the Trustees of the Board.
 - d. No amendments to the deed/ Bye laws shall be made which may prove to be repugnant to the provisions of sec 2 (15), 11, 12, 13 and 80 G of Income Tax Act 1961 as amended from time to time.

7. The Board shall have full power to file and defend suits, appeals, applications, etc. and any one or more of them, being duly authorized, and shall have powers to declare, sign and verify all complaints, written statements, memos of appeal, cross objections, applications, affidavits, etc. and to accept summons, notices, etc. and to appear in any

The Board members shall pay themselves and defray and satisfy out of the Trust funds/ property for the time being all expenses which they may reasonably have to incur in and about the execution of the Trusts and powers herein contained and the administration of the Trust property hereby effectuated.

10. The Board may acquire by purchase, hire, mortgage, lease, will, gift or to receive or accept grants, donations, subscriptions, contributions from any person, body or government organization any property, moveable or immoveable, or in any other form, for funds, from time to time as deemed expedient for furtherance of the objective of the Trust.

11. The Board may construct buildings, or structures or to maintain, develop, improve, alter, demolish, reconstruct any building or structure to further the purpose of the Trust.

12. The Board may alienate, mortgage, lease, hypothecate, pledge, or hire with or without security any property or funds of the Trust as deemed necessary to further the purpose of the Trust.

13. The Board may borrow or raise funds with or without security in any manner the Trust may deem fit and repay the same.

14. The Board may negotiate with and enter into agreements with any Government, Board, Authority, Corporation, University, Public and Private bodies and to receive such grants, loans, allowances, rights, and privileges as the Trust may deem fit to accomplish the objective of the Trust and utilize the same for the benefits of the Trust.

15. The benefit of this Trust and the income from the Trust property shall be given to persons irrespective of any religion, caste, creed or community.



VII. ADVISORY COMMITTEE: The Board may constitute as and when required an Advisory Committee of members not exceeding 15 in number by inviting the reputed members of the society who are willing to serve the cause of the Trust for a period and purpose as the Board may deem fit. A person who is invited shall make an application in writing to the Board which shall consider the application and on approval by 2/3rd majority the said person shall be deemed to be a member. The member so admitted shall pay annual subscription of five hundred Rupees (Rs.500.00). The Board shall be competent to remove any member of Advisory Committee for the reasons as deemed fit. A member is entitled to resign from the Advisory committee. The advise of Advisory Committee shall be advisory in nature and not mandatory for the Board.

VIII. OFFICE: The Office of the Trust shall be located for the time being at the Office of the Superintendent of Police, Mysore District, Jalapuri, Mysore - 570 019 and later at such other place or places as the Board may deem fit.

15. The benefit of this Trust and the income from the Trust property shall be given to
persons irrespective of any religion, caste, creed or community.

VII. ADVISORY COMMITTEE: The Board may constitute as and when required an
Advisory Committee of members not exceeding 12 in number by giving the required
members of the society who are willing to serve the cause of the Trust for a period and
purpose as the Board may deem fit. A person who is invited shall make an application in
writing to the Board which shall consider the application and on approval by 2/3rd majority
the said person shall be deemed to be a member. The member so appointed shall pay annual
subscription of five hundred Rupees (Rs.500.00). The Board shall be deemed to remove
any member of Advisory Committee for the reasons as stated in a resolution is called as
resolution from the Advisory Committee. The advice of Advisory Committee shall be advisory in
nature and not mandatory for the Board.

VIII. OFFICE: The Office of the Trust shall be located for the time being at the Office of the
Sub-divisional Officer, Mysore District, Jalpet, Mysore - 570 012 and later at such other
place or places as the Board may deem fit.

DISSOLUTION: The Trust created by these presents shall be irrevocable provided that in the event of the Trust failing to function for any reason, or in the event of Trustees being of the unanimous opinion that this Trust should be dissolved or amalgamated with any other Trust having the objects more or less similar to this Trust the Trustees may apply to the authority prescribed by law for permission to dissolve or amalgamate with any other public Trust and in that event the Trust property shall be transferred to that Trust with the consent of such authority as aforesaid, on such terms and conditions as the Trustees with concurrences of such authority may think fit.
